

# Pfizer knew their vaccine would kill

## Own data show shocking number of fatalities and side effects now officially associated with covid shots

**THE documents were first leaked in a cyber attack on the European Medicines Agency website. More than 40 megabytes of classified information from the agency's review were published on the dark web, and several journalists including those at the British Medical Journal were sent copies of the leak.**

In the U.S., the Food and Drug Administration had previously agreed to withhold the documents and their jaw-dropping revelations from the public for 75 years, until Texas District Judge Mark Pittman ordered their release within eight months, stating it was 'of paramount public importance'.

Most alarmingly of all, the documents show that in the trials there were at least 1,223 deaths reported in the first 28 days after injection.

The NHS, media and the government continually state that the vaccines are 'safe and effective' while those that report vaccine-related injuries via the Yellow Card scheme are often accused of making false correlations or imagining their symptoms.

However, the Pfizer documents

paint a very different picture, listing thousands of side effects that occurred at an alarming rate, which were as a direct result of taking the experimental genetic injection.

According to their report, Pfizer hired 600 extra staff to handle the sheer number of adverse reactions from its covid-19 shot, and said it had planned to hire 1,800 in total.

Serious side effects included, but were not limited to: auto-immune disorders; blindness; diabetes; herpes; heart problems such as myocarditis; thyroid disorders; neurological conditions such as multiple sclerosis; seizures; epilepsy; narcolepsy and Guillain-Barré Syndrome.

Non-fatal conditions such as eczema, blisters, asthma, fertility problems, inflammatory bowel disease, deafness and even tongue biting are also listed among the side effects by Pfizer.

While it has been approved for use in pregnant women, it is also known to cause pregnancy complications, including many spontaneous abortions. One of the many issues it causes is anaphylactoid syndrome of pregnancy or ASP for short.



ASP is a fatal disease for mothers and is among the leading causes of maternal mortality. Symptoms include severe bleeding, confusion, shortness of breath and anxiety. There is therefore a high risk for pregnant women taking the covid 'vaccine'.

The Pfizer document also lists various blood disorders, Crohn's disease and liver failure as side effects. Blood clotting was another issue reported from the trials.

One of the most telling side effects listed is... covid-19. Proponents often argue that despite the possible side effects associated with some of the covid shots, they at least prevent people from dying from covid-19.

The problem is that the 'vaccine' actually causes people to develop the disease, and so it is contributing to the number of cases, listing covid-19-associated pneumonia as a side effect.

Some may argue that these problems are only associated with the Pfizer shot, but death and serious injuries have been present and publicly acknowledged with all of the manufacturers' injections.

Research developed by Edinburgh University showed that almost 350 Britons have been struck down with a rare clotting disorder after getting the AstraZeneca vaccine.

These blood clots cause minor bruising around the body and can leave some with a purple-dotted rash.

The Moderna vaccine has been associated with heart problems such as myocarditis and pericarditis. Their list of adverse reactions also includes inflammation, fainting and breathing difficulties.

Data from the UK Health Security Agency (UKHSA) in the table on page 2 has also revealed that both covid-19 deaths and cases were worse in vaccinated people, particularly those over the age of 18. The official data is clear: the chances of developing covid-19 increases significantly following subsequent 'booster' jabs.

This is broadly in line with the information contained in the Pfizer document, which states that the shots cause covid-19 and respiratory illnesses.

Coupled with the fact that ONS data recently revealed that covid deaths were much lower than previously thought, the risks of taking the vaccine seem to greatly outweigh the risks of not doing so.

# An epidemic of cardiac arrests

Hidden killer revealed within shocking ambulance call-out data

**THE official line is that weekly reports of people collapsing in the stands at football matches are no different to normal, except in the past the matches would not have been stopped. There may be an element of truth in this, but the rise in ambulance calls for cardiac and respiratory arrests suggests that people are right in their suspicions and that there are good reasons for genuine concern about the health of the nation's hearts.**

The UK reports detailed and timely public health data, something of which we should be very proud. A weekly report from the ten English ambulance trusts shows numbers of calls for cardiac or respiratory arrests. The two are grouped together as it is not always clear whether a cardiac arrest was precipitated by a respiratory arrest.

The data shows two anomalies: a significant rise in arrest calls since spring 2021 and a significant rise in the number of expected arrest calls in the baseline figure.

The latter is important, as deciding whether there is a problem is critically dependent on knowing what normal levels should be. There is no text in the reports detailing why the baseline has shifted so dramatically. The expected number of daily arrest calls rose suddenly in March by about 50 per day - around 30% higher than before.

Other publications have shown such shifts when additional trusts are added to the dataset, but all the ambulance trusts have been reporting data throughout this period. What is more, the baseline for other conditions, e.g., overdoses and falls or injuries, has remained constant between 2019 and 2021. The only other baseline that has shifted significantly is that for chest pain which has risen from a steady 1,600 per day to 2,000. The number of calls for chest pain remains around the previous baseline of 1,600.

Another explanation could be that


the shift in baseline is caused by a change in the years included in the calculation. The baseline is usually made up of the previous five years, so in 2019 it would have included

calls are almost identical - only a 0.2% difference. However, the 2021 baseline was inflated by 14%. Using the 2019/2020 baseline, the number of arrest calls has been 30% above expected levels, with 27,800 extra arrest calls. That amounts to over 500 extra arrest calls every day (although they were not evenly distributed through the year). Between 90 and 97% of these people will have died as a result.

Given the uncertainty about the reason for the rise in baseline, there must also be some uncertainty around the 27,800 figure. However, it is fair to say there were 20,000 more arrest calls in 2021 than in 2019: a 20% increase. This compares to an increase of 6,000 in 2020 compared to 2019: a 6% increase. Whereas the increase in 2020 was clearly associated with the covid waves, the increase from May 2021 has been high regardless of covid prevalence.

When a football match is suspended, the reality of a sudden illness in a sick parent or grandparent



2014-2018 and in 2021 it included 2016-2020. If 2015 had a particularly low level of arrest calls then removing it from the baseline would cause a rise. However, this would be expected to occur from 1st January, not March. The reason for the rise in the baseline therefore remains unexplained.

The original data reports the daily numbers, as well as a seven-day rolling average. Prior to 2021, the peak daily calls were around 400 arrest calls in a day. However, this winter the peak surged beyond an unprecedented 500 in a single day.

It is notable that the 2019 and 2020 expectations for the number of arrest

hits home. When a number is presented on a graph, a distance is created from the hurt that is caused by that event.

Those matches are just a sample of the population, and for every father taken away by ambulance while his daughter goes home with a friend, there were around 70 others not in a stadium who were similarly affected that day. Taken together with the rise in excess deaths in the young and the rise in deaths at home, there is a hidden, non-covid public health crisis happening that is causing far more harm than this year's dominant respiratory virus.

# Covid-19: The revelations will not be televised

Media turning blind eye as pandemic narrative crumbles

**THE pandemic pantomime appears to be ending, but the show is far from over. Those once ostracised for their pursuit of truth are being vindicated by revelations seeping into the public domain, albeit mostly under the mainstream radar.**

In the last few months, we have seen reports confirming that lockdowns failed to save any lives from covid - unsurprisingly, this was only picked up by a few news outlets. A recent inquiry also confirmed that Sweden's decision not to impose a lockdown was the right one, as those countries which did went on to experience worse outcomes (see page 17 of this issue of *The Light*).

For instance, most of the covid-labelled deaths in England and Ireland occurred during the lockdowns. The impact of the lockdowns led internationally renowned epidemiologist Jay Bhattacharya to declare them the 'single biggest public health mistake in history'. The collateral damage from these measures will be felt for years to come.

The government was able to impose these societal restrictions through control of the media and the use of 'hard-hitting emotional messaging' to exaggerate the threat of covid-19. A group of psychologists have since declared the methods used to scare the public into compliance as 'grossly unethical'.

Media outlets challenging the mainstream narrative have been censored and lambasted for spreading 'dangerous misinformation'. The recent furore regarding guests on Joe Rogan's popular podcast has amplified this issue, with guest Maajid Nawaz exposing the use of 'military-grade psy-ops' via the deployment of the British Army's 77th Brigade on social media.


The highly controversial face coverings have come under the spotlight with a recent study showing they do 'little if anything' to prevent the spread of covid. The flawed PCR tests have also been questioned as they are unable to ascertain infectivity and mistake colds and flu for covid.

Since mid-June 2021, NHS England has been publishing data on the proportion of covid inpatients being treated primarily for the virus. During the height of 'omicron' this dropped to less than half. The ONS recently released data on the number

of deaths from covid alone and the figures were barely ten per cent of the overall total of covid-related deaths.

One may conclude that the threat from covid has been grossly exaggerated from the beginning. Though in the early government and HSE press conferences, we were told that covid was a 'mild disease'

from which most would speedily recover. No wonder Downing Street had few qualms about hosting parties during the first lockdown - they just chose not to publicise this fact until 18 months later.

Some of the more alarming impacts of the covid response remain buried in government reports and anecdotes from whistleblowers. The recently published list of adverse vaccine events seems to have conveniently coincided with blanket media coverage of other world events deemed more newsworthy.

Clips of MP Christopher Chope discussing the scale of the 'vaccine nightmare' have since been removed by YouTube as 'medical misinformation'.

Despite this, the vaccine rollout

continues with 5-11 year-olds next in line, even though it could take two million shots to prevent just one ICU admission in healthy children from this age group. Would people still rush to roll up their sleeves if they understood the difference between the publicised 95% relative risk reduction and the 1% absolute risk reduction from the Pfizer trial, the integrity of which has been brought into question by a whistleblower exposé in the *British Medical Journal*?

Claims that the vaccine has saved more than 100,000 lives seem wildly inaccurate given that more people died with covid during 2021 than in 2020.

Despite the media focus on the Wuhan lab-leak theory, one alternative explanation around the origins of the virus remains conspicuously absent from corporate reporting. Don't expect any mainstream media outlet to highlight the fact that over 170 Freedom of Information requests from health institutions in 25 countries have failed to show proof of the existence of SARS-CoV-2, or that it causes covid.

At the beginning of the pandemic,

we were told that excess deaths are the true measure of its impact. However, most commentators failed to notice that we were observing negative excess deaths before the first lockdown commenced. It is perhaps no coincidence that following the discharge of 40,000 in-patients by the NHS, there were 40,000 excess out-of-hospital deaths during the first wave.

While the covid narrative has begun to eat itself, the media focus has rapidly shifted to the latest moral panic intended to consume the attention of the masses. Although we can expect little from the recently-announced covid inquiry, *The Light* paper will always endeavour to bring the under-reported and censored facts to the public.

# Scotland issues very few covid jab exemptions

**FOLLOWING a refusal to grant a member of my family an exemption for the experimental covid 'vaccine' - I decided to find out exactly how many people in Scotland had been officially medically excluded from this massive medical experiment. The reason my interest was heightened is that the senior consultant to this family member initially agreed, in writing, that an exemption should be granted. He saw 'no pressing reason for a "vaccine" to be given'.**

A formal exemption was requested and a period of weeks passed, so I grew suspicious. Sure enough when contact was made again, this consultant had changed his views and now recommended vaccination. No way were we going to follow his advice, but the trust was shattered.

I have also heard of people suffering a serious adverse reaction to a first or second dose, and despite this, the medical staff still recommended they get subsequent doses. This goes beyond any comprehension of 'first do no harm' and 'duty of care', as well as 'informed consent' and has destroyed my trust in the medical profession.

And when the government, media and legal profession are already totally untrustworthy, it completes the tearing up of our social contract.

When I made a Freedom of Information (FOI) request to all the Scottish health boards for details of the number of medical exemptions granted, there was an element of evasiveness from some of the boards as well as the Scottish Government, but we got there in the end.

The Scottish Government said it was nothing to do with them, some boards said it was the responsibility of the Scottish Government or the National Services Scotland agency; National Services Scotland said it was nothing to do with them, but in the end provided the figures.

Some requests I asked of National Services Scotland went unanswered such as: 'Please provide any written direction to medical departments regarding not issuing medical exemptions'. I wanted to see a name on a directive, as this issue needs accountability.

The figures from each health board and National Services Scotland are shown on the right. For a population of well over five million people, I find it shocking that for an experimental product with poor efficacy, terrible short-

term data, and no long-term data, only 12 people initially, and a further 24 people, have officially been granted exemptions.

If data protection rules allowed us to go further and analyse the exact demographic these exemptions are in, we may perhaps find that the additional 24 are for medical staff, concerned about the possibility of mandates for their profession coming to Scotland, hence the sudden flurry of exemptions granted latterly.

I believe a day of reckoning is coming, and when the many pieces of the covid jigsaw come together, criminality with foreknowledge will be proven.

These FOI requests show intent on behalf of the medical establishment to do harm to members of the public, given that adverse effects and injuries from these novel and experimental injections have been known about since early 2021.

Legal challenges were also being prepared all over the world, with lawyers such as Robert F Kennedy, Reiner Fuellmich, Michael O'Bernicea and Judge Anna Von Reitz.



This, then, was the context of our local action. Having, between us, qualifications in counselling and psychotherapy and with one of us being a BPS Chartered Psychologist, we knew all too well what devastating effects draconian lockdown restrictions were having on people's mental health. In late 2020, we agreed that something needed to be done locally for the sake of everyone's mental health, not just the vulnerable.

It was on the basis of the testimony from all of the above-mentioned experts, along with our professional judgement as psychological therapists, that about half a dozen of us in Stroud (Gloucestershire) decided to start walking around the town wearing Citizens' Conversation sandwich-boards, inviting healing conversations with the public. We made such excursions on a regular basis around Stroud town centre starting in November 2020.

On Saturday, January 9, 2021, three of us were walking around Stroud wearing our Citizens' Conversation

sandwich-boards, talking with anyone who engaged us, as our way of supporting the local community at a time of great crisis. We were duly arrested near the High Street by an aggressive police officer 'for breaking coronavirus regulations' by holding an alleged 'gathering'. With grotesque irony, when we were arrested, Richard House was talking with a healthcare worker who was clearly upset at what was happening under lockdown, and desperately needed someone to speak to.

Our core concern with this legal case is the attack on civil liberties and common law rights that this illegitimate arrest represents, and through this legal case we are determined to help draw a clear line in the sand on these grave issues so that, in future, the police are not able to overreach their powers and encroach any further into our already fragile civil liberties. We are determined to have this case heard by a jury - and by a specially convened People's Jury, if necessary.

The UK Office for National Statistics has reported a near doubling of rates of depression since the pandemic began, and with the recently published Harvard University meta-analysis report, the evidence is now clear that the lockdown restrictions we were challenging were doing far more harm than good - which is exactly what we were saying at the time.

What a nadir we have reached when free men voluntarily offering a community service in the midst of a national crisis are arrested and punitively fined. To date, we have been fined well over £1,000 between us for the above 'transgressions', and we are now seeking to appeal this overreach outrage by the state and its judicial system. We currently need to raise £4,000 to bring this legal challenge. Victory against this iniquity would set a vital legal precedent for future comparable situations, and we would welcome readers' support.

# How the world was conned

Review of the film  
*The Viral Delusion*

**WATCHING this documentary, I wondered if the true story of covid-19 will ever supersede the official narrative.**

Directed by Mike Wallach, *The Viral Delusion* explains how the purportedly novel coronavirus was generated, how it spread through pseudo-scientific testing and how it persuaded most of the world's population to take a series of improperly tested injections. The vaccine cannot vaccinate against a disease diagnosed by a test unable to distinguish a virus that doesn't exist.

The featured clinical experts, including psychiatrist, Andrew Kaufman, natural physician, Tom Cowan, AIDS researcher, Kevin Corbett and Kiwi doctor, Mark Bailey (husband of Sam, a popular medical myth-buster) have consistently argued that covid-19 is a scam. The authorities have tried to silence them but they have never been proved wrong in their assertions.

According to Kaufman, Cowan and many, SARS-CoV-2 is merely a genetic data sequence. The reported isolation of the virus entailed human nasal samples grown in a culture of monkey kidney cells. The antibiotics added to the mix killed cellular material, causing debris (exosomes). The outcome of this process, a computerised model of strands of RNA, did not need a virus at all.


The film briefly looks back at the origins of germ theory, fast-forwarding to the AIDS epidemic in the 1980s, when Anthony Fauci of the National Institutes of Health warned of a new plague. However, the existence of the disease and its supposedly causative virus HIV was based on dubious evidence. The PCR test was deployed despite its inventor, Kary Mullis, warning against its use for diagnostic screening: with enough amplifications anything could be found. A vast AIDS industry emerged, abetted by mass media.

Officially, the covid-19 outbreak erupted from zoonotic transmission at a food market in Wuhan. As this city is also the site of gain-of-function research on bat coronaviruses, many sceptics suspected a lab leak as the true cause (whether accidental or deliberate).

Cases were redefined from persons displaying symptoms to anybody testing positive on the manipulated 45-cycle PCR test. Exposure of the fraud, such as the Tanzanian president's reporting positive PCR results in samples taken from goats, pawpaw fruit and motor oil was ignored or ridiculed.

Sick until proven healthy was the new doctrine. Government psychological campaigns convinced citizens that they were all potential silent spreaders of a deadly microbe.

Dreadful decisions were made by



doctors and health administrators in their covid fugue. Ventilators were hurriedly manufactured to fulfil extra demand, but this apparatus was effectively an instrument of euthanasia, with few patients surviving the ordeal of a machine taking over their breathing. Rather than a last gasp for the severely ill, some ambulant cases were immobilised, to reduce the risk of infecting others.

Destructive lockdowns and deprivations of liberty were imposed for a respiratory illness clinically indistinguishable from influenza.

When the average age of death in Italy was reported as 83, clearly vulnerable people were succumbing to pneumonia as always. The public was fooled into fearing a distinct syndrome, with the hallmark loss of taste and smell.

As I wrote in *The Light* (January 2022), many sceptics were prone to such persuasion, believing that any bad cold or flu they experienced in the last three years was covid-19. In this stupendous marketing success, first the flu was rebranded; then the 'milder Omicron form' replaced the common cold.

How was this elaborate hoax, with such devastating consequences, possible? A frequent challenge to the clinicians featured in the film is the consensus against them. But most doctors know little about genomics, and any doubters were deterred by the sanctioning of dissidents by the medical establishment. Several of the film's contributors have been censured and smeared, evicted from social media and their jobs, and their professional registrations threatened.

The vaccines were approved by regulators funded by Big Pharma, and promoted by the corporate media funded by the Gates Foundation. Doctors knew that the injections were experimental and hazardous, but went along with the regime. The UK paid £26 for each 'vaccinated' patient in a practice.

Jessica Rose, who warned in *Cardiology* about the risk of myocarditis, told the film that her article, written with Dr. Peter McCullough, was removed by the journal. The Hippocratic oath of 'first do no harm' has been abandoned.

*The Viral Delusion* is a compelling scientific counter-attack; lengthy at over two hours, but readily accessible in content and tone. This polished production is the first part of a series of correctives to the covid conspiracy and highly recommended.

# Lies, statistics and government agencies

**IN February, Public Health Scotland (PHS) stated that they will no longer publish data on covid-19 outcomes (cases, hospitalisations and deaths) classified by injection status, a hitherto valuable component of the vaccination surveillance strategy.**

They said their decision was based on ‘anti-vaxxers’ “inappropriate use and misinterpretation of the data when taken in isolation without fully understanding the limitations.”

However, PHS themselves are guilty of misinterpreting and misrepresenting the information to the public.

PHS have redefined the booster ‘vaccine’ population in a way to artificially and misleadingly reduce the rate of deaths of those boosted relative to the unvaccinated population.

PHS’s conclusion that individual death rate with covid is significantly lower in the booster than the unvaccinated population covid is false, being based on inappropriate analysis and scientifically-flawed interpretation.

Throughout the past two years, PHS have provided reliable data quantifying the impact of the Scottish government’s covid-19 response on the health of the population.

In particular, they have documented the unprecedented excess deaths that occurred last summer and autumn, prompting an official enquiry as to the cause, and uncovering a spike in September in the number of newborn deaths in Scotland that is also under investigation.

However, their latest decision, no longer to publish data on covid outcomes by vaccination status because they are being misinterpreted, has generated considerable adverse comment.

Claims have indeed been made about the deleterious effects of covid injections that go well beyond what can be supported by PHS’s published figures. However, critical appraisal of these unsubstantiated claims, rather than the blanket withdrawal of valuable information, would seem the best antidote to the spread of such misinformation.

In taking their decision to abandon the reporting of covid outcomes by vaccination status, PHS have effectively claimed the scientific high ground, suggesting they alone are the source of reliable data and sound interpretation - a position justified only if the information provided is above reproach, untainted by bias or misrepresentation.

To investigate if PHS possesses the scientific integrity they claim, I have sought evidence from their final report on covid-19 outcomes by vaccination status. The data I have investigated are found in the table and are shown here for the week 29 January - 04 February 2022.

It gives for the unvaccinated and boosted populations of Scotland the number of deaths with covid for the week, the estimated sizes of the respective populations, and a statistic to quantify death rates in each population - the Age Standardised Mortality Rate (ASMR) per 100,000.

Unvaccinated	13	1,524,406	10.95 (3.40 - 18.50)
Booster	73	3,229,938	1.50 (1.15 - 1.85)

A superficial inspection of this table would suggest to the casual reader that the death rate with covid-19 for those who have received a booster is far lower than for those unvaccinated.

Enquiring readers might wonder how one value could be used to quantify death rates in unvaccinated and booster populations, each of which comprises individuals of very different ages and death risks. However, such readers are likely to assume that PHS know what they are doing, have overcome this problem and the solution lies somewhere in the obscure calculation of the ASMR statistic.

Given that PHS are generally regarded as an official, authoritative government body, there is no impediment to the casual reader’s accepting the conclusion, explicitly stated by PHS, that “the death rate in individuals that received a booster or third dose of a covid-19 vaccine was between 4.6 and 9.5 times lower than individuals who are unvaccinated or have only received one or two doses of a covid-19 vaccine.”

However, there are many reasons to doubt PHS’s strong conclusions in favour of receiving a booster injection.

I will describe two of the most serious, although more could be cited.

The first problem concerns the definition of the booster population used by PHS, for which I must seek guidance in Appendix 6 of its report. Here I find that the booster population is not, as I might naively have assumed, the number of individuals who have received a booster injection, but rather the number that have received a booster

at least 14 days prior to the reporting of the death with covid.

If an individual suffers a covid-related death within 14 days of receiving their booster, they will not be counted as a death in the booster population, but as a death in the population that received two doses of vaccine.

This misattribution is likely to have significant consequences because deaths from adverse vaccination reactions principally occur shortly after vaccination.

The only possible effect that the PHS’s redefinition of the booster population can have is, artificially and misleadingly, to reduce the reported rate of deaths in the PHS booster population.

The second problem I have found with PHS’s analysis concerns the methods used to deal with the confounding factor of age. The purpose of any report on death rate by vaccination status should be to allow the reader to judge whether their individual risk of death is lower, the same or higher when vaccinated.

Given that the risk of death with covid depends critically on age, with much higher risk in older than in younger cohorts, meaningful reporting requires comparisons of covid mortality by vaccination status within defined age bands e.g. comparison of unvaccinated and boosted mortality rate within the 40-49 years age range. PHS have failed to provide such information relating to individual risk.

Instead, the statistic that PHS have provided (ASMR per 100,000) is one that simply quantifies the impact of a disease on total mortality in a population. It tells us nothing about the individual risk posed by a disease to a particular member of that population who is of a particular age - the critical information needed.

Despite presumably knowing that the ASMR statistic describes impact on a population, PHS nevertheless calculates this statistic and interprets the values calculated (10.95 and 1.50 for the unvaccinated and booster populations respectively) as measures of individual mortality risk in boosted and

unvaccinated populations.

There is no justification for drawing this conclusion. As I have emphasised, the statistic calculated is neither suitable for, nor capable of quantifying, individual risk of death with covid in the unvaccinated and booster populations.

The PHS analysis shows clear evidence of bias and gross misrepresentation of the data - not a firm position from which to attack the

scientific integrity of others.

Similar shortcomings in the handling of covid-19 data by another official government body, the Office for National Statistics (ONS), have recently been uncovered through dedicated critical analysis by independent researchers. The revelations indicate that all deaths in the first two weeks following vaccination have been removed from the data published by ONS, rendering it corrupted, and any conclusions drawn from these data worthless.

These instances highlight a systemic problem with the reporting of public health data by government agencies.

Government agencies are uniquely privy to hugely important and detailed information whose analysis and interpretation affect the lives and livelihoods of literally millions of people. Yet the reports that they produce on these data are not critically filtered and validated by the independent peer review process to which all other science is subject.

Instead, the public are asked to trust the scientific integrity of these agencies, many of whom are now reliant in part

on funding from foundations that have vested interests in the results reported.

The solution to the problem would be to make the raw public health data collected by government agencies, once suitably anonymised, publicly available for researchers outside government, ensuring that the agencies’ analyses could be openly scrutinised and critically appraised - and was no longer sheltered from justified scepticism behind a wall of data secrecy. It would also allow a far wider range of researchers and analytical techniques to be employed, maximising the benefit that can be derived.

This request for free access to public health data is perfectly reasonable, given that the public pays for its collection in the first place.

Nowhere is the necessity for public sharing of health data more desperately needed than for the dataset collated by the covid-19 vaccine Yellow Card adverse event reporting scheme. This was established to rapidly detect safety signals produced by the experimental covid-19 vaccines used in the UK for which no long-term safety data are available. The only defence that the public has against unchecked vaccine damage is the speedy recognition of dangerous safety signals documented by this passive reporting scheme.

Yet once again, despite the public purse being crucial in collecting and collating data, the government body responsible (MHRA) refuses to release the anonymised data for public analysis. This is indefensible, given that the data are routinely transferred to the vaccine manufacturers who have contributed nothing to their production.

The MHRA claim in each of their reports that there is no safety signal to see, but has failed to provide a single scientific study based on the Yellow Card data to support this claim. The lie to their reassurances is given by nearly 1,000 individuals who are now seeking compensation for severe injury and death resulting from administration of the covid shots.

The only way to hold failing public health bodies like PHS, ONS and MHRA to account is to insist that the dangerous information monopoly they enjoy is broken.

Raw, anonymised data must be made public to ensure impartial, critical, thorough and innovative analysis by those within and outside these government bodies.

# Alleged police brutality against peaceful protesters

Smartphone videos record 'brutal assault' on woman having panic attack

**I am increasingly aware, in these chaotic and challenging times, that there is a clear choice to be made: to either step up, and be the change I want to see in the world, or let the fascist steamroller roll right over me.**

I am already a part of this growing movement to take back our rights and freedoms, through my daily life choices, my community involvement and by taking personal responsibility for what is my 'stuff'.

I am currently committed to bringing a civil action against the Metropolitan Police, for the denial of my human rights, specifically the right to peaceful protest. It is my intent that this will provide the basis for a class action.

On the November 28 2020, I was present at what became known as 'The Hillingdon Siege', when a coachload of approximately 40 people were detained and held against their will by the Metropolitan Police at Hillingdon tube station.

Two coaches had left Bournemouth to participate in a peaceful protest against the lockdowns in London. On stopping at Fleet service station on the M3, a policeman approached the coaches and wanted to know where we were going and why. We were told the coaches had to have vehicle checks and we could not continue on our journey. This was both unsettling and alarming, and we were detained at Fleet for at least an hour.

Once we were allowed to leave, we were told that we could be arrested for breaching the Coronavirus Act, if we chose to continue to London. One coach returned to Bournemouth and I was in the coach that continued to London. We left Fleet, with a local police escort, which was replaced by an escort from the Metropolitan Police on the M25.

The police directed us off the road to Hillingdon tube station, where up to 100 police officers awaited us. At this point it felt like we were living in a police state and that democracy was only an illusion. A senior police

officer came onto the coach and told us that we were in breach of the Coronavirus Act, that we had to give our personal details and then we would be allowed to return to Bournemouth. Anyone who refused would be liable to arrest.

Emotions were naturally running very high as people were in shock, and frightened by what was unfolding. Many of our number filmed the events on their smartphones, and uploaded the live footage to the internet - there was widespread horror when people saw what we experienced on that coach.

We were not permitted to leave the coach, even for the toilet, and unable to access the toilet on the coach, since the aisle was filled with police officers - with no social distancing! We were held at Hillingdon for around three hours.

They were uninterested in engaging in any dialogue and showed no compassion or respect for our welfare. I am aware of nine people being arrested, including an elderly couple in their 70s and a young woman who was having a panic attack. I was asked only once for my details, which I refused to give, and I was not asked again. We were held on the coach against our will, although

we had not broken any law nor committed any crime. The experience was extremely stressful and designed to frighten and intimidate us.

One particular incident stands out as a clear illustration of how the police in particular, and the state in

general, have little or no regard for our rights, freedoms or well-being.

The young woman having the panic attack, in her distress attempted to get off the coach, but because the aisle was full of police she could not avoid pushing past them. One officer then arrested her for assault, and her treatment was brutal. She was bent double over a seat and her hands wrenched up behind her to be cuffed. The whole incident was filmed and shows her, in effect, being violently assaulted by the police. On her release, her body bore multiple bruises, which were recorded photographically by her family. The charges against her were eventually dropped when her lawyer told the police they would have their day in court with their photographic evidence. This young woman was traumatised by her ordeal and all who witnessed it were deeply disturbed and distressed.

The police's actions opened my eyes fully to the lie that we live in a democracy, and the truth that the state is deliberately trying to take away our rights and freedoms. However, it has only served to strengthen my resolve and say: 'no'. It was intended that an action would be taken against the police immediately after the Hillingdon Siege, but for various reasons it didn't happen. I

decided independently to take up this fight to hold the police accountable for their actions, and contacted the organisation Liberty, who were able to advise me that there is a clear case to answer. Since the end of last summer, I have been busy gathering witness statements, researching legal representation and media coverage. It has been, and continues to be, a very steep learning curve.

The most important point is that the story is told and reaches as many people as possible. I will not stay silent; I have a voice and I will use it hopefully to inspire and encourage others. I know that the only way we will change what is happening in the world today is to put out a strong vibration, based on love and compassion, and to continue to say 'no'. I don't doubt that powerful forces, maybe beyond our comprehension, are hearing us. We will prevail; truth and justice are on our side.

# Street lights have been weaponised

Wireless radiation can make targets feel suicidal

**The purpose of this article is to create greater awareness of the new weaponised LED (Light Emitting Diode) 5G streetlights. People really need to understand what is going on here. Looking on Facebook, there are at least fifty 'Stop 5G groups'; every major town and city has one - they understand how dangerous it is.**

I have been personally affected by these new streetlights since Birmingham City Council Lighting Department tested the 5G function of them in December 2019. They are situated in front of my house and in the roads around the estate. I am electrosensitive, which means that I am able to feel and am adversely affected by radiation from mobile phones and masts, as are nearly a million other people in the UK ([www.es-uk.info](http://www.es-uk.info)). I immediately felt this radiation when it was turned on.

The effects were instant whenever I answered the front door or went near any windows in my house. The immediate depressed mood, desire to commit suicide was intense. Exposure in line with the streetlight during the day for only a few seconds would produce these effects. When I moved away, they would pass in about ten minutes, and I would be back to normal. This would happen several times a day before I learned to avoid this exposure.

I phoned the Streetlighting Department, and the result was they turned the 5G RF radiation function off for all the streetlights in the vicinity of my house. Wonderful! I was back to normal life until they came on again on January 1, 2020. This time the Department said responsibility had been passed to the firm Amey who had the contract for maintenance with the council. I contacted them but they didn't respond. This situation has continued for the last two years. The effects of the radiation have resulted in my only being comfortable to relax or read in the cloakroom/toilet of

my house. Often, I have to take my meals in there as I can suffer in both the lounge and the dining room. I cannot go into the garden for more than 10 to 15 minutes, even while wearing a full protective suit made of anti-5G fabric.

Barrie Trower, former Royal Navy microwave weapons' expert, has stated that radiofrequency radiation (RFR) is the same as the radiation emitted by mobile phone masts and by the 5G-emitting streetlights that have been recently installed across practically every city, town, village and hamlet and many motorways and secondary roads in the UK. 5G involves the use of ever higher radio frequencies - up to 60, 100 and 1,000 GHz, compared to the 2.45 GHz that is used by WiFi routers.

Britain's 5G network is to include new equipment installed on road signs, bus shelters and traffic lights according to the *Daily Mail Online* on February 9 2022.

It was when reading the statements below, made by experts in microwave weapons about what can be done with them, that I recognised my own symptoms.

Says Barrie Trower, British military, retired, expert in microwave weapons: "If you are targeting demonstrators (with Radio Frequency radiation), you make them suicidally depressed. They don't care about demonstrating any more because they are too upset. With one pulse frequency you can make people so suicidal they cannot be bothered to act like a demonstrator anymore. All they want to do is sleep or lay in bed all day."

If you have new streetlights in your road, you need to consider when they were turned on and what unexplained symptoms you or your family might have developed as a consequence. If you do have symptoms, you must reduce the radiation that is under your control, i.e., turn off phones, smart meters,

ditch smart watches, wireless personal alarms, cordless phones and wifi routers, and unplug all new electrical appliances when not using them. Get everything switched to ethernet cable to get on the internet. Any computer shop can help you do this. In fact, many are going further, getting rid of 'smart' phones.

These new weaponised streetlights have been fitted in the area where I live, and unsurprisingly I am suffering the very same symptoms described by Barrie Trower including sudden onset depression and the desire to commit suicide, upset stomach, itching skin, painful joints and muscles, extra systole heart beats, heart arrhythmia, tinnitus, profound lack of motivation, etc.

The 'Global Smart Street Lighting & Smart Cities' market forecast (2019-2028) indicates that 'streetlighting was previously viewed as a major cost - up to 40% of a city's energy budget -

streetlights are now viewed as a "revenue opportunity".'

Nearly 200,000 scientists, doctors, engineers, citizens and organisations have signed an international appeal to stop 5G. A copy of the petition was handed to Downing Street on January 22 2020.

The best article to explain the dangers of EMF/RFR (Electromagnetic Fields/ RadioFrequency Radiation) to date is, 'Are You Swimming in an Invisible Sea of EMFs? Here's What to Do' by Dr Joseph Mercola. He says, "the telecommunication industry has manipulated federal regulatory agencies, public health authorities and professionals through powerful and sophisticated lobbying efforts leaving consumers confused and unaware of the health risks associated with EMFs."

# A brief history of the technocracy

**In 1919, the Technical Alliance of North America was formed in New York, with a reputable multidisciplinary membership from science, education, architecture, mathematics and medicine. The group drew on the principles of scientific management of FW Taylor (initiator of the production line at Ford Motor Company).**

In 1932, its leader Howard Scott met, and soon after joined M King Hubbert at Columbia University, New York. Under the new name of Technocracy Incorporated, Scott and Hubbert presented a blueprint for a North American Technate, a highly regulated society with control of energy, based on constant monitoring of citizens. The main objectives were organisation of all industry into a few centrally-planned corporations, equal state income for all (now known as universal basic income), with bureaucracy and scientific experts replacing political government.

Bankrolled by the Rockefeller Foundation, Technocracy Inc. had a large membership in North America in the 1930s. Members distinguished themselves by their coats and suits of a particular shade of grey; they also bought cars in that colour, with orange hub caps. However, the heyday was brief, partly because the radical plan was a bridge too far for technology of the time, and also due to the overshadowing New Deal interventionism of Franklin D Roosevelt. Technocracy Inc. was riven with opposing factions, some supporting the government, but others frustrated by its slow progress and missed opportunities. As war broke out in Europe, leading members urged Roosevelt to declare himself as dictator.

Three decades later, David Rockefeller wanted the best brains on his pet project to solve global problems of the present and future, including relations between capitalist and communist countries and the impact of population growth in the developing world. Like Technocracy Inc., many of these minds were from Columbia University (also the seat of cultural Marxist Herbert Marcuse). On 23 and 24 July 1972, seventeen chosen experts in finance, international relations and political science met at the Rockefeller estate in Pocantico Hills, upstate New York, to create the Trilateral Commission. At a final planning meeting in Tokyo in January 1973, chairmen were appointed for the three regions of trilateralism: Western Europe, Japan and North America, with Zbigniew Brzezinski as director. Headquarters were sited in Manhattan.

In October 1973 the executive committee of the Trilateral Commission warned that while the threat of nuclear war had diminished, 'new problems have emerged to heighten the vulnerability of the planet', and that 'humanity is

faced with serious risks to the global environment'. Following in the footsteps of Technocracy Inc, the Trilateral Commission espoused supranational control of resources and population. Energy would be the currency. Cash, private ownership, elections, free speech and protests would be abolished, enabling a coterie of experts to reign unhindered by individual rights or elections.

In a 1974 article in Foreign Affairs, a publication of the Council on Foreign Relations, economist and Trilateral Commission member, Richard Gardner, described the 'hard road to world order'. The strategy would ensue not by sudden shock but by stealth; a frog would immediately jump out of hot water, but would not react to slowly boiling water until too late. A gradual globalist coup would thrive on episodes of disorder, exploiting a 'booming, buzzing confusion'.


An important objective was control of the media. Heads of national television networks and prestigious newspapers such as the *Washington Post* and *New York Times* were invited to join the Trilateral Commission, on condition that proceedings remain private. This ethically dubious practice has corrupted the mainstream media; journalists know on which side their bread is buttered. Approaching the 1976 presidential election, the Trilateral Commission exerted its considerable media influence in its determination to get the right man in the White House.

Public awareness of this shadowy but highly influential organisation was minimal but for the investigative work of Anthony Sutton and Patrick M. Wood, who produced the twin-volume *Trilaterals* over Washington (1979, 1981). However, the Trilateral Commission has successfully stayed out of the limelight. To most ordinary people, its role in American politics is an untold story; neither the organisation nor Brzezinski are mentioned in standard

texts on modern US history, despite their seminal role.

In the UK, the Trilateral Commission worked behind the scenes on foreign policy, hastening the transition of Rhodesia to independent Zimbabwe under Robert Mugabe. Prime Minister Jim Callaghan was a member, as became his foreign secretary David Owen, and so too was his counterpart in Margaret Thatcher's government, Lord Carrington. Several Tory ministers have contributed to the Trilateral Commission's pursuit of an 'international rules-based order'. Of particular interest is Sir Keir Starmer,

a Trilateral Commission member for many years, who became Labour Party leader after only one term as a member of parliament. Since legacy leftist Jeremy Corbyn was ousted, Starmer has resumed the centrist progressive policies of arch-globalist Tony Blair.

The Trilateral Commission has had considerable influence on the United Nations by pushing the doctrine of sustainable development, which really means control of food, fuel and other resources. However, while members continue to occupy positions in the Washington 'deep state', the Trilateral Commission has been overshadowed by the World Economic Forum (WEF). Led by Klaus Schwab, a German financier of

Rothschild lineage, the WEF is less shy of publicity, holding annual conferences at Davos in Switzerland attended by the media.

Like the Trilateral Commission, the WEF is tightly engaged with the United Nations, promoting Agenda 21/2030 and calling for urgent action against 'anthropogenic climate change'. The World Health Organisation, a previously unremarkable UN agency, suddenly became powerful in response to the covid-19 pandemic, directing national governments in imposing unprecedented 'lockdowns' and mass vaccination with digital passes. Draconian restrictions on livelihood and liberty were fully supported by opposition parties; indeed, Keir Starmer regularly urged stricter measures, despite disproportionately affecting the socio-economically disadvantaged constituency that Labour is supposed to represent.

Exploiting the emergency, the WEF has called for a 'great reset', as described by Schwab and Thierry Malleret in a book of that title. The abrupt 'new normal' envisaged by the globalists consolidates gains for the 'fourth industrial revolution', a concept promoted for many years by Schwab with striking similarities to the tentative plans of Technocracy Inc. almost a hundred years ago. Indeed, technocracy - the replacement of elected government by social engineering - is being realised by stealth. Artificial intelligence, a cashless society and digital passports for everyday activities are being introduced with little resistance, as people are duped

into accepting encroachments on privacy and freedom for convenience and safety.

A command-and-control system, technocracy is easily confused with either communism or mega-capitalism. But it has no interest in political ideology or a free market. China, under its notionally communist regime, is at an advanced stage of technocracy. Klaus Schwab speaks positively of China despite the obvious human rights abuses

of its social credit system.

In the West, the UN network of Smart Cities is redesigning urban life, restricting our freedom to gather socially, to speak freely or to protest, while obliterating privacy. Development of a central digital currency, proposed 'online safety' laws and the permanence of some covid-19 regulations demonstrate further progress.

At best, the technocrats are the town planners of the mid-twentieth century, on a grander scale. Concrete housing estates were meant to shape a new society, in defiance of individualist traditions ('an Englishman's home is his castle' and 'good fences make good neighbours'), but these schemes failed miserably.

There is nothing inherently wrong with collectivisation, but the social engineering of technocrats eschews the time-honoured identities of faith, flag and family. At worst, they are forging an almighty superstate that brings to life *Brave New World*, how Aldous Huxley imagined technocracy. In the 1940s, with the internet a distant dream, Orwell's *Nineteen Eighty-Four* presciently described a society controlled by video surveillance, while *The Abolition of Man* by CS Lewis warned:

"What we call Man's power over Nature turns out to be a power exercised by some men over other men with Nature as their instrument."

Whatever the origins of the outbreak (some suspect it was planned), covid-19 has certainly been exploited by globalists. Back in 2017, Klaus Schwab boasted of how the World Economic Forum was infiltrating governments around the world with its leadership programme. He specifically mentioned Canadian prime minister Justin Trudeau, adding that 'we penetrate the cabinet'; indeed, 'more than half of his cabinet are actually Young Global Leaders'.

Indeed, Trudeau imposed one of the strictest covid-19 regimes in the world, and when a truckers' protest against vaccine mandates camped outside the parliament in Ottawa, he invoked a state of emergency. His deputy, Chrystia Freeland (whose grandfather was a prominent Nazi), declared the freezing of protestors' bank accounts without trial. After riot police and army were deployed to brutally quash the peaceful protest, member of parliament Colin Carrie asked whether the WEF had too much influence on Canada, the speaker of the House of Commons said that he couldn't hear the question, before a minister stood up and accused the questioner of peddling conspiracy theory. Both of these appointees are members of the World Economic Forum, for whom there is apparently a conspiracy of silence.

# The arrogance of modern day medicine

Can medics who promote the narrative really be unaware?

**WHILE the cheerleading majorettes trumpeted the development and arrival of covid-19 vaccines in late 2020, a significant proportion of all populations in the firing-line, from all walks of life, instinctively exercised caution.**

As the zeal for injecting people on an industrial scale with an experimental product against a virus which was manifestly in decline, escalated to fanfare pitch, that caution turned to suspicion, and they started searching for scientific data that emanated from independent sources outside of government and pharmaceutical-funded institutions.

Early on, groups of independent specialists, like Doctors for Covid Ethics, formed to give the public an alternative perspective. They sought to explain the basic nature of diseases, how our natural immune system responds to them in a myriad of health sustaining ways, and what they had unearthed to date about these novel spike protein-inducing mRNA injections and their potential effects on the human body.

This they did through video presentations, open letters sent to regulatory agencies in which they raised their concerns, and expert

witness testimony analysis prepared for court cases challenging early mandates in Europe. In July of 2021, they brought together an international multi-disciplinary panel of professionals to present their first symposium, run over two days.

Two further symposiums have since been held by them. In the USA and Canada, many organisations of highly credentialed scientists from across the spectrum of specialities did likewise - America's Frontline Doctors and the Canadian Covid Care Alliance to name a few - giving generously of their time and energy to explain, inform and educate as the data emerged.

By late Summer 2021 there was a veritable flood of data coming forth, not only on the nature of the mRNA injections themselves, but of multiple harms of injury, life-changing disability and death following inoculation. And so I keep asking why, if so many lay people have applied themselves to absorb, understand and analyse medical and scientific data which raise alarm bells from Notre Dame to York Minster, are a seeming majority of medical practitioners so intent on burying their heads in the sand?

There are of course some notable and heroic exceptions to this paradigm in the form of principled and dedicated GPs and hospital physicians ready to lose their livelihoods rather than be coerced into having an unwanted and

unwarranted medical intervention, and they continue to be straight-jacketed in an increasingly weaponised NHS.

It's worth reminding ourselves that the medical-industrial-complex had its genesis in the U.S. in the early 20th century as a result of the invention of

hospitals, set up the General Education Board in 1903, hijacked the curriculum of medical training to teach students that modern medicine amounted to allopathy (the reversing of symptoms), which involved exclusively using patented drugs whilst demonising

petrochemicals, which enabled John D. Rockefeller to create a monopoly of the oil, chemical and medical industries.

At the time, homeopathic medicine was widely practised in America, using ancient knowledge developed over centuries by Native Americans, of readily available herbs and plants as natural remedies for ailments, and holistic medicine was taught in colleges. Rockefeller 'gave' over \$100 million dollars to colleges and

and outlawing natural medicine, establishing the pill for an ill culture. The teaching of pharmacology overtook that of physiology.

More recently, Children's Health Defense conducted interviews of doctors across America asking what they had been taught at medical school about the various childhood vaccines and how they interacted with growing immune systems, and 100 per cent of those interviewed responded that

they had been taught zero about the vaccines themselves; all that had been drummed into them were the schedules of when they should be administered.

In 2002, Dr. David Sackett, considered to be the father of evidence-based medicine, wrote in a paper entitled *The Arrogance of Preventive Medicine*:

"Preventive medicine displays all three elements of arrogance. First it is aggressively assertive, pursuing symptomless individuals and telling them what they must do to remain healthy. Occasionally, invoking the force of law (immunisations, seatbelts), it prescribes and proscribes both individual and the general citizenry of every age and stage. Second, preventive medicine is presumptuous, confident that the interventions it espouses will on average do more good than harm to those who accept and adhere to them. Finally, preventive medicine is overbearing, attacking those who question the value of its recommendations."

On August 13 2020, John Keiger wrote an article in *The Spectator* entitled 'Why are so many dictators former doctors?' He references an in-depth piece of research published in *The Lancet* in 2017 and suggests: 'It should be made compulsory reading for members of the "doctocracy" who, with their new-found covid powers, are dictating policy across the world with little consideration for the wider implications of their edicts.'

Ultimately the covid coup has proved beyond doubt that, from the point of view of anyone not in the self-proclaimed 'elite' class, there are only two 'sides' to the conflict that is now developing - the worldwide banker oligarchy that thinks it has the right to rule over, steal from and manipulate mankind for the rest of its earthly existence, and every one else who desires freedom and independence.

It is this knowledge that our movement needs to focus on disseminating above all else.

I endeavour to do everything within my capability to champion and campaign for truth, honesty, integrity, sovereignty, freedom and real democracy. I will continue to inform the local electorate on important local and national issues and do everything in my power to make sure the voice of the people is heard, as it should be in a system like ours.

My campaign is 100 per cent people powered! No large corporations are funding me to help me put the power back into our local communities - why would they?









with those newly formed operations.

# Ukraine crisis accelerating rise of Central Bank Digital Currencies

A JOINT project between the Central Bank of Canada and the Massachusetts Institute of Technology will be researching the possibility of an entirely digital Canadian dollar, it has been announced.

The digital dollar would be a state-issued cryptocurrency, or Central Bank Digital Currency (CBDC).

It's not just Canada - countries from all around the world appear to be accelerating the research and implementation of CBDCs as we enter the second quarter of 2022.

In our New Year's post, *Off-Guardian* anticipated that the introduction of Central Bank Digital Currencies would be a major news thread of 2022, and that prediction looks to be coming true already.

CBDC pilot schemes were already being conducted in the Bahamas, Nigeria and Jamaica before the end of 2021, with the latter planning a full rollout later this year.

Dozens of others are not far

behind, including the U.S., UK and the entire Eurozone. Sweden's 'e-Krona' is currently in the testing phase. Joe Biden has called research into CBDCs a matter of 'highest urgency'.

Ukraine is right at the forefront of CBDC research and has been preparing for such since 2016. There were plans to implement one later this year, though it's possible the war has changed them.

The Russian central bank was developing a "digital ruble" before the invasion of Ukraine, and it is now being suggested as a way to circumvent Western sanctions.

China was already leading the race to total digitalisation of their currency, and have used the 'vulnerability to Western sanctions' as an excuse to push ahead even harder.

India, South Africa, Malaysia... the list goes on and on.

In short, pretty much the whole world has been at least considering

the move to entirely digital money.

Why should this concern you?

Well, because a digital currency would mean every single transaction you make can be monitored and recorded by the state, as well as your bank. The implications for the right to privacy are obvious, but privacy is the least of it.

Much of the research being done on CBDCs concerns making them programmable - meaning either the state issuing the money, or the company paying it as wages, could put controls on when, how or where it is spent.

To quote a *Telegraph* article from last autumn:

"Digital cash could be programmed to ensure it is only spent on essentials or goods which an employer or government deems to be sensible."

As I wrote in October last year:

"Governments and employers making sure the money they issue can only be used on 'sensible' things, and not be used in 'socially harmful' ways? It doesn't take much imagination to see just how

this system could evolve and re-shape society into a truly dystopian nightmare. It wasn't hard to imagine then, now we don't need to imagine. They have shown us exactly how they would use that power."

Just a month ago, the Government of Canada was tracking down Freedom Convoy protesters - and even those who just donated money to the protests - and ordered banks to freeze their accounts. Consider how much easier an entirely digital currency would make that process.

Not only would it be easier to seize people's assets, but you could stop people donating to the 'wrong' causes in the first place by changing the 'programming' of your digital money.

Reader-funded alternate news sites - very much including *Off-Guardian* - could find themselves branded 'harmful misinformation', and placed on the 'funding blacklist'.

People who refused the vaccines, or don't publicly denounce Russia (or any passing enemy of the

moment), could have sanctions placed on their bank accounts.

Western governments are currently declaring financial war on dozens of private citizens who have not been charged - let alone convicted - of any crime, just because of their nationality. It's being done under the guise of "punishing dirty Russians" - but what can be done to an oligarch can be done to anyone.

Essentially, anyone who doesn't support the current thing would be living under the threat of financial ruin.

The possibilities are as endless as they are terrible. Central Bank Digital Currencies are a death knell for the very idea of individual freedom.

It's almost impossible to overstate the importance of this.

# ‘We will all die of a total lie’: Bishops condemn artificial pandemic and Vatican stance

**THE early months of 2020 were marked by an outbreak of an infection which caused less deaths than ordinary seasonal flu.**

An artificial pandemic not only affected healthcare, but also paralysed the economy, education, private life, and undermined morale. The Vatican has taken an active part in this artificial pandemic. Through his unGodly activities, Pope Bergoglio has consciously brought a curse on the Church and humanity. This Pope has cynically boycotted the urgent warnings from experts against the mRNA vaccination, and forced the whole Vatican to get vaccinated - all except three guards have succumbed.

The Byzantine Catholic Patriarchate (BCP), on the other hand, has supported the true stance of scientists with integrity, who have stood in defence of truth against the system of lies.

They include top U.S. scientists such as Dr. Judy Mikovits and Dr. David Martin, Czech microbiologist Soňa Peková, and Prof. Alexander Redko from Russia. Let us briefly mention the scientific conference in St. Petersburg held on October 20-21, 2021 and the summit of physicians in Rome on September 12-14, 2021 where over 12,700 doctors and scientists signed the Rome Declaration. They referred to the forced experimental vaccination as a crime against humanity as defined by the Nuremberg Code.

Dr. David Martin: “This is not a vaccine. This is an mRNA packaged in a fat envelope that is delivered to a cell. It is a medical device designed to stimulate the human cell into becoming a pathogen creator. It is not a vaccine... Vaccines actually are a legally defined term. They are a legally defined term under public health law and under CDC and FDA standards.

“You are getting injected with a chemical substance to induce illness, not to induce an immuno-transmissible response. In other words: nothing about this is going to stop you from transmitting anything. This is about getting you sick and having your own cells be the thing that gets you sick.”

Dr. Judy Mikovits: “It is a synthetic pathogen. They have literally injected the very pathogenic part of the virus into the body... it can directly cause multiple sclerosis, Lou Gehrig’s disease, Alzheimer’s disease - because that’s what the expression of that pathogenic envelope is; it can cause accelerated cancer... That’s what the expression of that piece

of virus has been known to do for decades. You are injecting the disease - literally.”

Immunology expert, Professor Alexander Redko from St. Petersburg, said: “I spend time in the hospitals where they treat covid patients. I am well informed; I follow the development and I know what is going on there... and it is mostly those that had been vaccinated that get sick. They develop all the obvious coronavirus symptoms. According to the data from pathoanatomists, more than 62% of those who are hospitalised at the inpatient departments for covid patients are fully vaccinated.”

QR codes designate those who are good and those who are bad. The healthy ones are the bad ones, the sick and vaccinated ones are the good ones. That is what QR codes indicate; nothing more.

There is no pandemic. To qualify for a pandemic, epidemics must be present in all countries. But there are no epidemics here. To qualify, it is necessary for 5% of the population to be sick at the same time.

The PCR test is made for viruses with a long chain, and this is a virus with a short chain. It means that it is from a completely different area. It is not possible to use it to identify the coronavirus.

We will all die of a total lie. Because no matter where you go, you will find a lie.

To give antivirals, ones that aren’t specifically against SARS-CoV-2 - is a crime. And that can be found in the protocols of the Department of Health! What should be done with the Department of Health? You need to answer that yourselves.

Now you make isolated weirdos of us all. You will lock us down and transfer the children to remote learning to destroy our immune health.

This is not a pandemic, but an infodemic, and all that is going on is politics and a socio-economic experiment on the population.

Sputnik V - that is not Sputnik ‘Vee’, but ‘Five’, because it is only the fifth vaccine which they have worked on in the entire history of their company. And they have not managed to do one successfully.

I think that it is necessary to get vaccinated if a) there is a vaccine, b) if the virus does not mutate, or in other words, if the vaccine can help fight against what is present in

the environment.

The virus that used to be here a while ago is no longer here. The thing they want to develop a vaccine against - and which usually takes six years to make - that virus is no longer here. There are some delta variants, they can call them whatever they want, but that is something already completely different. And you are saying that you are getting vaccinated against something that was here two years ago? They say that the vaccine does not help any more, because we have a new mutation here. So why do you keep vaccinating? If you really care that much, make a vaccine against the current mutation - but you can’t!

That is why what they are offering us is not a vaccine. It is adenovirus 26, adenovirus 5, on which they put spike protein - and why? That is not clear. Because SARS-CoV-2 has never been isolated. A reward of 1.5 million Euros was offered for someone to isolate it. And if no one had ever isolated it, what are you actually vaccinating against? Why are you deceiving people? This is a commercial project.

And I insist that it is not possible to even discuss it, since a) the virus has not been isolated, b) there is no vaccine against it, c) clinical trials will be completed on December 31, 2022. The trials have not been completed, the results of the first phase when all the rats died have not been published. The results of the third phase likewise are not published as the trials have not been completed. Antibodies titer has not been determined, anti-epidemic impact has not been identified, the immune response has not been specified - what kind of results are these? The project must be shut down instead of continuing the mass ‘vaccination’.

But people don’t know it. They say: “I was vaccinated. I am fine.” 25% of people are injected with a placebo, that is what makes them feel good and that is why they get sick again. But those who got really vaccinated get more seriously sick. And they get a full-blown coronavirus with all the post-covid symptoms - lung damage, central nervous system damage, Guillain-Barré syndrome and all other issues.

Everything that accompanies covid, the same is present with the vaccine reactions. And I have many acquaintances and acquaintances of my acquaintances, who a) got sick and b) are no longer alive - after the shot.

## Sweden justified in implementing only minimal lockdown rules

**SWEDEN’S well publicised covid policy of no lockdowns during the past two years has been deemed ‘fundamentally correct’ according to a government-approved safety commission.**

was fundamentally correct. It meant that citizens retained more of their personal freedom than in many other countries.”

Despite praising the overall covid response, the panel reported, “In February-March 2020, Sweden should have opted for more rigorous and intrusive disease prevention and control measures.”

Sweden unfairly received criticism from many Western nations for its stance on covid. The Scandinavian country opted against implementing harsh lockdowns and closing schools. Instead, the Swedish Government and health officials recommended to its citizens a voluntary approach in managing covid, with a strong emphasis on personal responsibility.

A panel of eight experts including professors of economics and political science examined Sweden’s unique covid response. The commission stated in its final report: “In comparison with the rest of Europe, Sweden has come through the pandemic relatively well and is among the countries with the lowest excess mortality over the period 2020-2021.” The report added, “Focusing on advice and recommendations which people were expected to follow voluntarily

Health Minister Lena Hallengren responded to the report’s findings by saying: “The non-lockdown policy has been much debated. I’ve had to answer a lot of questions during the pandemic about the “Swedish strategy”. The fact that the commission concluded that the overall strategy, based on non-invasive recommendations... was the right choice. I think that’s good.”

The report highlighted the worldwide issue of handing too many powers and responsibilities to government-approved health agencies. “In a crisis, there must be no uncertainty about who is in charge,” the commission reported.



## South African doctor told to stop labelling the omicron variant as mild

**ONE of the first doctors in the world to assess and treat the omicron variant was told to stop playing down the mild features of the variant. Dr Angelique Coetzee, a South African GP was one of the first doctors to discover the new variant in November 2021.**

In an interview with the Australian *Daily Telegraph*, Dr Coetzee reported, “Because of all of covid’s mutations, all of these scientists and politicians who aren’t from South Africa were contacting me telling me I was wrong when I spoke out, that it was a serious disease... they were telling me I had no idea what I was talking about, they kept attacking me. In South Africa, it is a lighter disease, but in Europe it has been a serious, serious illness, which is what the politicians want me to say. There has been a lot of pressure from European scientists and politicians who have said ‘Please don’t say it is a mild illness’.”

Dr Coetzee told German newspaper *Die Welt*, “I was told not to publicly state that it was a mild illness. I have been asked to refrain from making such statements and to say that it is a serious illness. I declined.”

She added, “In the Netherlands, in the UK, scientists asked: “How can you explain that it’s a mild disease? It’s a serious illness. Look at the mutations.” My reports have thrown them off track. In a pandemic, you also have to look at what is happening at the grassroots level. The general practitioners who treat the sick every day must be asked what they experience, how the clinical picture presents itself.”

Many countries will never admit their part in whipping up mass hysteria, especially regarding the mild omicron variant. One hopes that more doctors like Dr Coetzee will bravely speak out on what they see or don’t see in their work health settings.

# Russian scientists facing witch hunt

Scientific interactions between nations are needed for peace and harmony

**WHEN the West goes full throttle into condemning and sanctioning Russia's invasion of Ukraine, do they really consider the consequences? It is generally understood that gas and oil prices will go up like a rocket (scare mongering intended). But something the sanctimonious may not consider is how the 'war' will impact on science.**

Universities UK, which represents the nation's vice chancellors, advised its members to review collaborations with Russia on a case-by-case basis. Their official stance states that they are "appalled by Russia's actions" because their "unprovoked" invasion would lead to a humanitarian catastrophe. ## U.S. media in U-turn over Hunter Biden laptop

**AFTER calling it 'Russian disinformation' before the 2020 presidential election and helping to effectively cover it up, the corporate media machine is now admitting the laptop which revealed criminal behaviour by the President's son is genuine.**

Twitter blocked the *New York Post's* revelations in October 2020, contained within a trove of emails, text messages, photographs and financial documents that were found on a laptop which Hunter abandoned at a Delaware computer repair shop in April 2019.

Headlines which the media failed to print just before the election in 2020 could have presented stories about Hunter Biden's illegal business dealings with, among others, China and Ukraine.

Further, videos of the U.S. President's son appeared to show him smoking crack cocaine, but were wiped from all but the darkest parts of the internet.

Such revelations would have damaged then candidate Biden's chances, and with a four-year history of smearing then sitting U.S. President Trump in any way they could (including a 2-year investigation into 'Russian collusion' which came to nothing), it is no surprise that the corporate media would then cover up for his rival in order to help get him elected.

But on March 16, the *New York Times* confirmed several previously reported aspects of the story, including correspondence between Hunter and his business partner Devon Archer, both of whom served on the board of Ukrainian energy giant Burisma.

On March 30, the *Washington Post* and *CNN* piled on - with the *Post* confirming yet more details of the laptop contents, and *CNN* running a segment and reporting that the federal investigation into Hunter is 'heating up'. The *Washington Post* reported on Hunter's "multimillion-dollar deals with a Chinese energy company".

Glenn Greenwald tweeted: "Most of these details were reported and confirmed in several outlets before the 2020 election - as opposed to now when it's safe to say it - but they were censored by Twitter based on the CIA lie spread by most corporate outlets that it was 'Russian disinformation'."

## European Medicines Agency investigates menstrual problems after covid jabs

**THE European Medicines Agency (EMA) is currently reviewing a possible link between menstrual irregularities and covid shots after thousands of women reported changes post-injection.**

On the February 11, the EMA issued a statement on their official EU website: "The Pharmacovigilance Risk Assessment Committee (PRAC) is assessing reported cases of heavy menstrual bleeding (heavy periods) and absence of menstruation (Amenorrhoea) with the covid-19 vaccines Comirnaty and Spikevax.

"The Committee had previously analysed reports of menstrual disorders in the context of safety summary reports for covid-19 vaccines approved in the EU and concluded at the time that the evidence did not support a causal link between the vaccines and menstrual disorders.

"In view of spontaneous reports of menstrual disorders with both vaccines and/or findings from the literature, the PRAC decided to further

assess occurrences of heavy periods or Amenorrhoea following vaccination.

"Menstrual disorders are very common and can occur with a wide range of underlying medical conditions as well as from stress and tiredness. Cases of these disorders have also been reported following covid-19 infection.

"Heavy periods may be defined as bleeding characteristics by a volume which may interfere with the woman's physical, social, emotional, and material quality of life. Amenorrhoea may be defined as the absence of menstrual bleeding for three or more months in a row.

"After reviewing the available evidence, the PRAC decided to request an in-depth evaluation of all available data, including reports from spontaneous reporting systems, clinical trials, and the published literature.

"At this stage, it is not yet clear whether there is a causal link between covid-19 vaccines and the reports of heavy periods or Amenorrhoea. There

is also no evidence to suggest that covid-19 vaccines affect fertility.

EMA will communicate further when more information becomes available."

A major study from the Norwegian Institute of Public Health examined the link between covid vaccines and menstrual changes. Results from the study found that there was a high incidence of menstrual changes after inoculation. The study collected data from over 6,000 women aged 18-30.

Project Leader at the Norwegian Institute of Public Health, Dr Lill Trogstad reported: "Menstrual changes are very common, and even before vaccination, almost four out of ten young women reported that they had experienced such changes. However, in this study we see that more women experienced changes after the first or second vaccine doses."

Government and health officials who coerced millions to get jabbed under the guise of 'safe and effective' vaccines need to be answerable to the public, as adverse reactions keep emerging all the time.



## Switzerland rejects funding for state media corporations



**SWITZERLAND has voted to strongly reject government plans to increase state funding for media organisations. The referendum was directly related to a Bill approved by the Swiss Government in Bern to grant aid for media companies around 150 million Swiss francs a year.**

Switzerland utilised its direct political decision-making process by holding a referendum on the issue. Opponents of the Bill gathered thousands of signatures in a petition to set up the vote, using the unique system of democracy in Switzerland known as 'direct democracy'.

Swiss French language newspaper *Le Temps* reacted to the referendum results by saying: "Whatever else one says, Sunday February 13 will force editorial offices to question themselves. The results show that the media are seen as complacent and subject to external influence... The only possible answer is to work even harder, to constantly search for opinions that contradict one's own, to continue investigative

journalism and field work, and to be innovative. The Swiss media will have no choice but to prove that they are indispensable even in a society dominated by Google, Facebook, and co."

Zurich-based newspaper *Neue Zürcher* also posted: "The rejection of additional financial aid could also be a reaction to reporting in coronavirus times. The media's credibility has been put to the test in these last two unusual years. Their conspicuous closeness to the state and the - as we now know - loyalty to the government of certain outlets imposed by their management must have shaken the confidence of many citizens in the fourth estate of democracy."

The full results from the Swiss referendum showed 54.6% voting against the financial package for the 'already bought' media corporations.

In a time of media mass control and hypnosis, it is positive to see Switzerland pull the financial reins in on an already compromised industry.



## Saudi carries out capital punishment sentences

**RIYADH, March 12, 2022:**

# Overcoming addiction

**IT would appear that thirty per cent of the population worldwide has addictive tendencies. This is partly to do with the fact that not all of us have a fully functioning dopamine system and a lack of dopamine is a problem for the addict.**

The problem with dopamine is that we have in our brain a regulatory mechanism that endeavours to keep our dopamine levels stable. When this happens, the addict compensates by increasing the level of intake of the stimulant. In response, the brain down-regulates dopamine absorption and a vicious cycle of addiction can begin. Getting that dopamine rush becomes increasingly elusive, and people find themselves checking their phone constantly to see notifications, or smoking, drinking, overeating, gambling - whatever somebody's addiction is, often leading to excess.

# Covid protocol successful

Over 1,130 covid patients treated with a nutrition-only protocol, with just one death

**COVID patients in the UK are being deliberately denied information on the huge success of non-jab approaches to treating the illness, despite widespread reports of the success, for example, of high-dose vitamin D (4,000 IU/day) and ivermectin in other countries (Japan recently licensed the latter across the country, resulting in a significant reduction in cases and deaths).**

In the U.S. Dr David Brownstein and his partners, based in Orchard Lake, Michigan, reported on their success with 107 consecutively presenting patients treated with nutrition only, of which all survived, in 2020.<sup>1</sup> That number is now in excess of 1,130 - with only one death!

The average age in their group is 55 years and they include many

overweight or obese, those with underlying comorbidities and those of Black or Asian origin (BAME). Nearly 20% of this cohort was over 70 years old. All of these four groups also tend to be highly vitamin D deficient.

This is the same approach that they have been using for over 20 years in treating all viral and bacterial infections. This therapy was designed to support the immune system during an infectious time period.

The treatment protocol used was:

At the first sign of illness, such as a cough, fever, sore throat, etc, the

patients were instructed to take orally a four-day course of 100,000 IU of vitamin A (not beta carotene), 1,000 mg of vitamin C every hour to bowel tolerance (loose stools), 50,000 IU of vitamin D3 and 25 mg of iodine.

Furthermore, the patients were advised to nebulise a dilute solution of hydrogen peroxide (0.3%) and iodine (1 drop of 5% Lugol's solution) every waking hour until symptoms improved. If further care was needed, the patients were treated with intravenous doses of vitamin C (2,500 mg, IVC), hydrogen peroxide and intramuscular ozone. No drugs were administered, except steroids occasionally, and no experimental 'vaccines'.

To date, they have had precisely one patient die! And there were just 12 hospitalisations out of over 1,130 patients. They have also had very few patients suffering from long-term effects secondary to covid-19: 15 of the cohort (2.9%). Most of these patients improved on a holistic regimen and no longer suffer from prolonged symptomology. As previously, Dr Brownstein hopes to publish these results in due course, though this is being made increasingly difficult due to journals rejecting such articles because they don't want to upset their drug advertisers!

"Becoming ill with SARS-CoV-2 and developing covid-19 is not a death sentence", says Dr Brownstein. "For most it is a mild-to-moderate, flu-like illness. When treated early with items that nourish and support the immune system, patients suffering from covid-19 can make a full and uneventful recovery."

Cancel culture and divisiveness do not belong here

**SOME balance is sorely needed in the local debate about the free, narrative-challenging newspaper *The Light*.**

You (the *Stroud News and Journal*) have to date published one report (with no response sought either from our group or from the newspaper itself,) and a number of letters criticising the paper.

It is only fair and a common courtesy that a considered response be published on your letters page.

The widely distributed Amplify Stroud leaflet about the newspaper claims that either *The Light* or our group is "spreading antisemitism".

This is an absurd and scurrilous accusation.

We all have Jewish friends, many of whom are great supporters of this newspaper and its courage in interrogating mainstream narratives in a way that the controlled mainstream media has abjectly failed to do.

Amplify Stroud's wholly disproportionate attack is based on just one article of perhaps 300-400 words since the paper was founded.



The short article in question was making the point - albeit with an arguably insensitively chosen example - that convicted paedophiles can receive shorter prison sentences than someone convicted for what they have said.

The article contains no antisemitic content, contrary perhaps to the impression given in Anthony Hentschel's letter of March 9. Yet it's on the basis of this one article that Amplify Stroud has based its divisive campaign - the result being a steady stream of hateful comments and confrontations aimed at us on Stroud High Street, often from people who have never even read the paper.

Cancel culture, anyone?

Unlike Amplify Stroud, *The Light* does not peddle a discordant 'anti' ethos. Rather, it is 'pro' free,

open debate (not monocultural censorship); 'pro' personal body autonomy (not 'mandates'); 'pro' fully informed choice and consent (not obfuscation and coercion-by-stealth); 'pro' uniting humanity (not divisiveness); 'pro' human-centred technology and well-being (not technocracy and industrial bio-pharmaceutical medicine) - I could go on.

Cancel culture, hate-mongering and divisiveness do not belong in our great town.

Three weeks ago, we wrote a detailed, conciliatory letter to the organiser of the Amplify Stroud campaign, offering a meeting and a conversation to seek healing and reconciliation. Your readers will reach their own view about the fact that three weeks on, we have received no reply to this peace-making offer.

We urgently need open-minded conversations and respect for difference in these challenging times - not the fuelling of division, othering and demonisation that merely feed and encourage the most base human instincts and behaviours.

**Note to reader:** The Prospect of Babel outlines a concept-polity, the purpose of which is to act as an index for social transition, that is open to revision, modification, moderation and so on (welcoming correction on every level, while inviting others to refine it – which renders the reader, in part, the writer, or leastwise the righter via critical reading).

To this end most of the commas are optional (being formal more than grammatical devices).
